(hereinafter referred to as the "TRUST FUND") for the object and proposes hereinafter expressed with the powers and on the terms and conditions herein contained concerning the same. The name of the TRUST shall be "BASIRHAT RABINDRA-NAZRUL EDUCATIONAL & SOCIAL WELFARE TRUST"

1) The office of the Trust for the time being shall situated at Vill.+ P.O.- Pifa, P.S.- Basihat, District - North 24 Parganas, West Bengal, Pin - 743422 until otherwise decided in the meeting of the Board of TRUSTEES by majority of Votes. The Board of Trustees shall have power to shift the office and open branch office.

2) The objects for which the "TRUST FUND" is established are General Education, Social & Cultural Education and advancement in general of Arts, Science and Culture etc, relief of the poor, Medical relief and advancement, Blood Donation Camp, Scout Group. NCC Training, Civil Defense Training, community welfare for other charitable object of general public utility not involving the carrying on of any activity for profit and for such purposes.

a) To establish, promote, support, maintain and grand aid or other cultural assistance to clubs, social organization, schools, colleges, & establishment of educational institutes (i.e. B.Ed. College., Primary Teachers Training Institute, Medical College., Engineering and Management Institute, M.Ed. Institute, B.P. Ed. & M.P. Ed. Institute, B.A - B.Ed, B.Sc. - B.Ed, University Etc) libraries, reading rooms, lecture halls museums, allow other Trust or Society to use the existing Trust brand with terms and condition and other establishments and institutions for the development of education and diffusion of knowledge.

b) To grant scholarship, stipends, free-studentship, prizes rewards and allowances or other financial assistance to students.

c) i) To establish and maintain homes, orphanages or other establishments for relief of and to give help to the poor and destitute people, orphans and widows and otherwise provide for them.

ii) To give award on all India regional bases to persons for their outstanding performances in the field of education, medicine, science, technology, sports and games, health or such other fields as trustees may decide.

d) To provide food, medicine, clothing and / or shelter for poor and / or needy persons and to give help to them either in cash or kind or otherwise.

e) To establish, maintain and grant aid or other financial assistance to hospitals nourishing homes, maternity homes, clinics charitable dispensary sanatoriums and other establishments for giving medical relief to the poor sick and physically and / or mentally handicapped persons.

f) To grant relief to the people affected by earthquake, flood, fire, famine, pestilence and other natural calamities of similar nature and to give donations, subscription or contributions to institutions, establishments or persons doing such relief work.

g) To render assistance and / or grant aid to recognized public charitable trust or institutions.

h) To give financial & cultural assistance to local Authorities. Municipalities and such other bodies engaged in public utility service.

i) To promote physical education and culture and to do all acts for improvement of general health and physical development and to give financial assistance to gymnasiums, Achaia's and other institution engaged in the above activities and to construct, run and maintain holiday home recreation center, Guest Houses, and Dharmashalas for the benefit of General Public.

j) Notwithstanding anything herein before contained the income of the Trust Fund shall be applied and be applicable only to or for such charitable or religious purposes only and within such territories only and subject to such conditions, or limitations if any as may from time to time be laid down in the ; Income Tax Act for the time being in force of if any other Act in modification or substitution thereof governing taxation of income for the time being in force as will ensue or earn or make the trust hereby established and its income as eligible for exemption from taxation under the Income Tax Act 1961 or any replacement re-enactment or modification thereof shall apply so that any donation to this trust be recognized as eligible for tax exemption in regard to the Donors and further so that the Trust hereby established shall be one of which the provisions of Sec. 80G of the Income Tax Act, 1961 or any replacement, reenactment or the modifications for the time being in force shall apply so that any

donation there to be recognized eligible for exemption or relief from tax in regard to the donors.

3) The TRUSTEES shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of Trust Properties of in relation to the carrying out of the objects and purposes of the TRUST as well as of all the assets, credits and effects of the TRUST PROPERTIES.

4) For the furtherance of the objects of the TRUST, the TRUSTEES will have the following powers :-

a) To collect funds and to accept, receive donation, grants-in-aid subscriptions endowment, Gift of money, lands building stocks, fund, shares, securities and any other movable or immovable properties from Govt. Municipality, Corporation and any member of the General Public or any other person, society, association, firm companying body corporate and to accept and take by way of gift and absorb the undertaking and property of any others society, trust, association or institution under any law of India having charitable objects and similar other objects of this trust and to undertake all or any of the liabilities of any such society, association or institution. Provided that the acceptance of such donations, subscriptions, contributions endowments of gifts offered and given without any condition and / or are not in any way in conflict with the basic object of the trust.

b) To apply the whole or part of the income of the TRUST FUND or accumulation thereof or whole or part of the corpus of the TRUST FUND for any one or more of the objects or the TRUST as the TRUSTEES may decide from time to time.

c) To vary and deal with the TRUST PROPERTY and / or to vary the investments for the time being.

d) To invest and keep invested the TRUST FUND either in the purchase or mortgage of immovable property or in lease shares, stock or debentures, or other securities and investments whether authorized by the Indian Trust Act 1882 or not or in deposit with or loans to any company, bank, firm or any other person in conformity with the provisions of the Income Tax Act for the time being in force, and to alter, vary or transpose such investments from time to time as the

TRUSTEES may in their discretion think fit for others of the same or of alike or different nature

e) To borrow or raise of secure payment of money and also to lend money either with or without security.

f) To sell, dispose of alienate or otherwise deal with any property comprising the TRUST FUND

g) To let out, denies any immovable property comprised in the TRUST FUND for such period and on such rent on such terms and conditions as the TRUSTEES in their discretion may think fit.

h) To open and / or close the Bank Account with any Bank or Co-operate such account and to give instructions to the Bank or to provided for opening and operation of such account by the one or more of the TRUSTEES or by an agent appointed by the TRUSTEES.

i) To appoint constituted Attorneys or Agent and to delegate to such attorney or agent all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his theirs place.

j) To make, very alter or modify schemes, rules and regulations for carrying out the objects of the TRUST and for the management of the affairs thereof and or running any institution in furtherance of the object of the TRUST and otherwise for giving effort to the object of the Trust.

k) To start, abolish, discontinue and restart any charity or charitable institution.

l) To set a part the whole or part of the income or the corpus of the TRUST FUDN for any of the objects of the TRUST.

m) To join corporate or amalgamate this TRUST with other fund having kindred or allied objects upon such terms and conditions as the TRUSTESS may in their discretion think fit particularly having regard to the objects and nature of this TRUST.

5) The TRUSTEES shall be chargeable only for such money, stock, shares and funds as shall actually come into their hands and they shall not be answerable or accountable for neglect, default acts of omissions or commission of the other TRUSTEES, nor of any Banker or other person with whom the Trust Properties or any securities may have deposited of kept, unless caused by their willful neglect or default.

- 6) The Trustees shall be allowed out of the trust fund all expenses actually incurred by them on its behalf and in the beneficent exercise of their duties for managing the affairs of the trust.
- 7) If any of the trustees or any firm of which he is a partner or director be employed as solicitor or advocate by the Trustees in any non contentions matter or judicial or judicial proceeding such trustee or such firm shall notwithstanding the fact of such trusteeship be entitled to all fees for such professional employment, Similarly such a trustee if he is employed as a broker, factor, agent or in any other capacity by the trust then such trustee shall be entitled to all remuneration for such employment irrespective of the fact that he is a trustee.
- 8) The number of the TRUSTEE shall not be less than two, if the number of the TRUSTEE shall fall below two, the Trustees shall not, except for the purpose of filling any vacancy act so long as the number is below the said minimum.
- 9) The TRUSTEE shall have power to co-opt TRUSTEE within the number mentioned above for such period and on such terms as to retirement and reappointment as the TRUSTEE FOR THE time being considered proper. The TRUSTEES appointed by the present will be for life. If any TRUSTEE dies, retires, becomes unfit or incapable to act, the continuing or surviving TRUSTEE or TRUSTEES will be competent to appoint a TRUSTEE in place of the TRUSTEE so dying, retiring or becoming unfit or incapable to act either for life or otherwise as aforesaid.
- 10) Any TRUSTEE may delegate in writing all or any of his powers under these presents to his nominee who will be entitled so long as such nomination remains in force to exercise such power or powers in the same manner as the TRUSTEE himself could do personally.
- 11) Every TRUSTEE will be at liberty to resign on giving one-month notice of his intention to do so.
- 12) The TRUSTEE MAY FROM TIME TO TIME FRAME RULES AND REGULATIONS for the conduct of the meetings of TRUSTEE in the absence of such regulation.
  - a) The Trustees shall form a quorum for a meeting of the trustees.

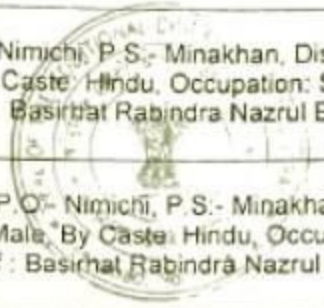
